54/16/3 Draft budget for 2017/18 The clerk distributed the first draft of the budget forecast for 2017/18. A decision on next year's precept will be made at the January meeting.

54/16/4 Section 106 the clerk reported that there are funds under section 106 which must be used by October 2017 and further funds available till 2019. Cllr Glanfield suggested that some changes could be made to the Church Surround. This will be considered at a later meeting.

55/16/1 Planning Applications.

DC/16/4322/TEL and DC/16/4296/TEL removal of telephone services from the telephone boxes in Henstead and Hulver. Following discussion it was agreed that no objection to the removal of telephone services from the two sites. On a proposition from Cllr Horwood seconded by Cllr Armstrong it was agreed that the council should purchase the red box in Hulver using the 'Adopt a Telephone Box' scheme operated by BT.

Council confirmed the interim decision to recommend approval on DC/16/3714/FUL Gate Farm Hulver a rear extension for Mr and Mrs Baker

55/16/2 Outcome of planning applications

DC/16/3714/FUL Gate Farm Hulver a rear extension for Mr and Mrs Baker WDC Permitted

55/16/3 Planning Appeal DC/16/0678/OUT. The clerk reported that an appeal had been lodged against WDC's refusal of the planning application for outline planning for a residence at the Rosary Hulver Street. The clerk reported the key issues outlined in

the appeal document, the requirements for infill, access to facilities and provision of sustainable public transport linked to an application for infill development. The clerk was asked to prepare a response to the appeal on behalf of the Council. **55/16/4 DC/16/3/FUL Construction of 1no detached house Land adjacent to Hall Cottage Henstead for Mr Carat Developments Ltd**. Council was updated on the outcome of the planning committee meeting of 13th September. **The application was refused.**

56/16 WDC report.

Cllr Rivett reported that the devolution issue has been deferred. There are a number of grants available that councils can apply for, Cllr Rivett will forward details to the Clerk. Cllr Rivett said that Brampton Parish Council had produced a very good questionnaire which might be useful to Henstead as part of their neighbourhood development plan.

56/16 Neighbourhood Development Plan

Cllr Horwood (Chairman of the Neighbourhood Plan Team gave a report on the progress of the Neighbourhood Plan. He welcomed several new residents to the team and that a productive meeting had made good progress on the area of consultation with residents. A further meeting has been arranged for 29th November to further develop the strategy. Cllr Horwood also asked for members to seek more residents who would like to be involved. It was agreed that we should write formally to Cllr Ladd SCC to secure a contribution from his locality budget to the cosatas of the NP.
