#### 47/19 Update on the Neighbourhood Plan

Cllr Horwood reported that he and members of the team met with members of the Reydon team and it had proved useful. Cllr Horwood said that following the adoption of the Parish Plan the Council should members of the Council and residents to undertake some of the tasks and roles identified in the plan. Cllr Horwood said that Cllrs Hadingham and Block had agreed to take on the issues relating to traffic. Cllr Horwood said that other roles would be filled in the near future and he would be approaching members to take on the roles in the plan.

Cllr Horwood reported that he and Cllr Hadingham had met with Cllr Ladd and Denise Mortimer, Highways Engineer to discuss options to take forward matters that could be used to improve road safety in the Parish. A traffic survey will be carried out in August to provide information about the volume, speed and type of traffic passing through the Parish. Highways Department will provide other information for future discussions. Cllrs Hadingham and Block will meet with Mark Nichols and Cllr Ladd to discuss the traffic surveys and roundels. It was further agreed that Members would attend the meeting about the Beccles Southern relief road on 2<sup>nd</sup> August.
