# 170/23/1 Suffolk County Council. Report from SCC Cllr Ladd:

There is currently a public consultation running for 10 weeks on the proposed Suffolk Devolution Deal. This is in two parts including an open survey that any resident can complete and a sample survey of 1000 residents. The proposed deal would mean the possibility of a directly elected leader.

The final piece of the Gull Wing Bridge is now in place. The bridge is expected to be open in the next couple of months.

The County Council has benefited from a 7.3million pound investment to the local electric vehicle infrastructure fund.

The Lowestoft branch of Suffolk Archives is set to close and be relocated to The Hold in Ipswich.

## 175/23 Parish Community Plan

**175/23/1 Highways** A discussion was held on the proposed traffic survey to be carried out on Toad Row. It was decided that, as a Speed Indicator Device can obtain the same data, the council would use it's current SID resources to survey the quantity and the speed of traffic using this road. Possible locations for the temporary positioning of the SID will be forwarded to the Clerk so that they can be approved by the relevant persons.

**175/23/2 Church Surround -** It was agreed that this would be discussed further at the May meeting with full council with a view to making a decision on how to take this forward.

**175/23/3 Communication including website -** The Clerk noted that work is continuing on the website to ensure that all pages are up to date and all links are working. The Clerk informed councillors that there may be a need for further consideration of moving to a gov.uk domain. This will be added as an item to a future agenda.

## 175/23/4 Amenities - No update

**175/23/5 Social Activities - DDay 80** Council discussed the prices of the DD80 flags. It was agreed that the Clerk would look to purchase 2 of the 5ft x 3ft flags at a cost each of £24 plus VAT. **Proposed by Clir Hadingham, Seconded by Clir Doran.** Councillors would look at possible locations to position the flags.

## 176/23 Additional Speed Indicator Device - Update

The Clerk confirmed that the Enabling Community budget form has been received from ESC and has been completed and returned. SCC Cllr Ladd will complete the form for the funding from county council following the PCC elections on Thursday 2nd May 2024.

## 177/23 Defibrillator - Update

Cllr Doran noted that he has now taken over the guardianship of the defibrillator located on the external wall of the village hall in Hulver. The pads will need to be replaced in August of this year. The expected price to replace these pads is £54.

## 178/23 Fly-Tipping at Latymere Dam - Update

It was noted that some of the rubbish may have been removed but there is still a large amount remaining. The Clerk will email East Suffolk Council regarding the options of managing this area going forward.
