#### 63/23 Reports

**63/23/1 Suffolk County Council.** SCC Cllr Ladd reported that half way through the financial year, SCC has a £23 million deficit, which equates to less than 4% of its overall budget. A 'no cold-calling' zone has been set up in Kessingland to help protect vulnerable people. The Gull Wing Bridge project has requested an extension to the closure of Denmark Road. The bridge is now due to open in 2024. SCC Cllr Ladd has recently visited the new Suffolk Fire and Rescue training centre in Wattisham.

#### 65/23/1 Email from Zurich Insurance

The Clerk informed Council that the insurance renewal premium had been received from Zurich Insurance, remaining the same cost as last year at £257.60. It was agreed that the renewal premium be accepted. **This was proposed by Clir Doran, Seconded by Clir Block.** 

## 65/23/2 Email from resident - 30mph extension to A12/Toad Row Junction

The Clerk informed council that a resident had forwarded a copy of a letter sent to SCC suggesting that extending the speed limit right to the A12 would be in the interests of all local residents. SCC Traffic Regulation Officer had replied to suggest this was raised with the Parish Council. After a short discussion, it was agreed that SCC Cllr Ladd would look to arrange a meeting with the Community Liaison Engineer and members of HHPC to discuss this and any other highways issues.
