25/24/1 Suffolk County Council. SCC Cllr Ladd reported that the AGM had recently been held, there is a new Chair and cabinet changes have been made. The motion on the agenda to support local councillors in the face of abuse was passed unanimously with cross party support. The Council has resolved to take a zero tolerance approach and is committed to the Debate not Hate campaign.

There has been a good response to the Suffolk Devolution Deal consultation which closed on 26th May. This has now been temporarily paused due to being in the pre-election period. A scrutiny meeting regarding Highways and the state of Suffolk roads had been planned for 4th July, this will now be rearranged.
