i) DC/23/1983/FUL Full planning permission for 1 No. Dwelling, to include access, parking and amenity land. Land south of Toad Row, Henstead, Beccles, Suffolk, NR34 7LG. Awaiting a decision

ii) DC/24/1381/FUL A 6 meter x 4 meter pent roofed timber shed with attached 6 meter by 3.5 meter carport, located in the South East corner of the property's boundary. The Old Chapel, Chapel Lane, Hulver, Henstead, Beccles, Suffolk. Application Permitted with a condition that the precise details of any external colour to be used shall be submitted to and approved by the Local Planning Authority.
